The following decisions taken by the Board in its 57th Meeting held on 14.09.2021 are hereby notified for implementation to concerned Branch(es) of this Board as well as to all the quarter concerned for necessary compliance :-

Item No. 11(3) Regarding consideration of matter to enhance the examination /registration /other fees due to steep hike in price index to make the Board financial sustainable in future.

The members of the Finance Committee felt that the rates of examination fee /registration fee & others fee are quite old and need to be revised in a phased manner to make Board self sustainable. Therefore, the members of the Finance Committee unanimously approved the revised rates partially of examination fee /registration fee & others fee as under:-

8.	Appeal fees for U.M.C. candidates.	@ Rs.600/- per candidate.
9.	Examinations fee for the Polytechnics students (Regular and Re-appear)	@ Rs. 500/- per candidate (per semester/per year)



10.	Examination fee for the students of NCVT/SCVT/ All India Apprenticeship Trade Test (Regular & Re-appear)	@ Rs. 500/- per candidate
11.	Registration fee (Polytechnics students)	@ Rs.400/- per candidate
12.	Registration fee (I.T.I students)	@ Rs. 300/- per candidate
13.	Affiliation fee (In case of fresh affiliation)	@ Rs. 50000/-
14.	Affiliation inspection fee	@ 20000/- per inspection.
